 - Another option – Cross blacktop road to strip job. Great place to ride. Already trails exist.

- City of Buckhorn offers Abners grocery & restaurant, gas, historic log church c. 1928, camping at Tailwater (may or may not allow horse trailers in campground).
- Squabble Creek General Store – Possible stop for supplies.
- Must cross Middle Fork of Kentucky River at one point to get to Buckhorn from Eagle's Landing.
- Connects with annual Crockettville ATV ride which goes into Culley Abner's property on the Breathitt County/Perry County line.
- Culley Abner willing to use his equipment to develop trails on his property, build stables, campground and more.
- Might suggest the focus be on developing ATV trails west of Buckhorn and ATV trails east of Buckhorn.
- Have verbal permission to use existing trails across numerous properties but not sure they will sign agreements.

Worthwhile sites include:

- Military Plane Crash – artifacts found. Mark Stidham may have a section of fuselage. (see contact below)
- Frontier Nursing in Leslie County. Used to be stables in Bowling Branch. May still exist.
- Sawmill once in operation at Landon Hollow.
- Eversole Log House c. 1800 – located on Judge Denny Ray Noble's property

Waterline access route would be good start for trail.

- A waterline access road was constructed when a water pipe was installed to the State Park. County received permission from USACE to extend the easement to allow for trail access. By doing so, it cut down the number of landowners needing to sign trail use agreements to one. To access the State Park, the trail must cross the property of Keith Miller with Keith Miller Construction.
